The eighth grade orchestra (and some 7th grade students) are performing for CPA (Concert Performance Assessment) on Thursday, March 7th at Furman University. We will leave Northwood Middle school at 8:30am and return to the school by 2pm.

## **How does Concert Performance Assessment work?**

CPA is a judicial event where three strings judges will be listening, recording, and giving written comments on how the orchestra performs. Their expectations are extremely high and all students must play, perform, act, and look professional. Once we arrive at the school, we will unload the bus and come into the building quietly into the warm-up/unpacking room where we

will tune and run through the music. After about ten minutes we will move onto the stage to perform our music. Afterwards, we will move to the sight-reading room where the students and myself have ten minutes to look at a new piece and then perform it to the best of our abilities. The judges will add all of the scores together once we are done and we will receive a plaque with our rating.

## What do the students wear?

The concert attire for everyone is white polo shirt for the top and black pants (school appropriate, and no jeans) for the bottom. Shoes need to be either black or white and please avoid colorful or bright shoes (no neon colors). The judges will take points off of the entire group if we do not match, so it is very important.

## Do we need help from parents to help chaperone the trip? YES!!

We will be taking one bus to Southwood Academy of the Arts and have 25 students. We need at least three chaperones. To be a chaperone, you must contact the Northwood office, 864-355-7000 or just stop by, and complete a form. Then you will be clear to be a chaperone.
